### **ITEMS REQUIRED** to Apply for a **SCIS Card:**

- **2 Passport Photos** (Canadian Passport Certified) **BEST PRICE for 2 Photos:**
  - **Costco** (requires membership) **\$6.99 + tax**
  - **London Drugs** **\$12.99 + tax**
  - **Walmart** is **\$27.99 + tax**
- **Bowlin PHOTO** (2439 Beacon Ave. Sidney) **\$17.99+ tax** **\$2 off** Coupon at...

- 1 or 2 (depending on type) pieces of Valid Government Issued ID
- **Marriage Certificate** **IF** 1<sup>st</sup> ID with new Family Name, **OR** Marriage has yet to be registered with Aboriginal Affairs and Northern Development Canada.

### **Children 15 years of age or Younger, OR a Dependent Adult:**

- Copy of Original LONG FORM Birth Certificate - states Parent(s) name(s)
- Applicant on behalf of the Child or Dependent Adult (signer) **MUST BE** the **Parent** or **LEGAL Guardian** (with papers to support Legal Guardianship); **Applicant's valid Photo ID**
- **Dependent Adult REQUIRES 1 of the following:**
- Order of Guardianship or Trusteeship, Power of Attorney, Trustee for the Personal Property, a Statutory Declaration witnessed by a lawyer.

### **★ Guarantor Required for ALL Applications involving SCIS Cards ★**

#### **The guarantor:**

- Must be 18 years of age or older.
- Must reside in Canada or the United States.
- Must be reachable for verification by the Department.
- Must have known the applicant personally for at least two (2) years.

**Note:** To know the applicant personally means that the guarantor is able to confirm information about the applicant, such as the name, approximate age, place of birth, physical description and some personal history such as place of residence.
