

### **TIMELINE**

#### July 2018

 BC Housing purchased MÁWUEĆ without consulting Tsartlip First Nation

#### 2018-2020

 Tsartlip First Nation notifies Province of BC about historic use and claim to MÁWUEĆ.

#### March 2020

• Tsartlip signs settlement agreement with the Province of BC to acquire and remediate the land, and to engage in community planning for the land.

#### April to December 2020

• Tsartlip pursues due diligence of the lands (environmental, regulatory, legal).

#### December 2020

• A Tsartlip First Nation-owned corporation acquires MÁWUEĆ.

#### 2021

Environmental remediation begins.

#### May 2021

• Tsartlip submits Addition-to-Reserve (ATR) proposal to Indigenous Services Canada (ISC).

#### September 2021

• ISC formally accepts ATR proposal.

#### Ongoing

- ISC and Tsartlip are completing the addition-to-reserve (ATR) process.
- Tsartlip First Nation is completing community engagements to understand the future vision of MÁWUEĆ.
- Restoration and environmental monitoring initiatives are underway.

# INFORMATION ABOUT MÁWUEĆ

Tsartlip First Nation brought MÁWUEĆ (also known as Woodwynn Farm) back under the Nation's stewardship in December 2020. MÁWUEĆ is located at 7779 West Saanich Road, just north of South Saanich IR 1 (see Map on last page).

# Significance of MÁWUEĆ

These lands were originally part of the WJOŁEŁP village site and were used by our ancestors for many purposes including hunting, fishing, gathering medicines, harvesting cedar, farming and ceremony. MÁWUEĆ also includes KENNES Creek where our ancestors would fish. The creek is called KENNES, meaning "whale" because a whale was once beached at the mouth of the creek.

## General Facts About MÁWUEĆ Lands

- → **Size and Location:** 78 hectares (192 acres), next to the north boundary of Tsartlip reserve South Saanich 1.
- → **Zoning:** MÁWUEĆ is held as fee simple which means the lands are subject to Central Saanich's Zoning Regulations. MÁWUEĆ is also part of the Agricultural Land Reserve (ALR). Until the lands are added-to-reserve Tsartlip First Nation is limited in the types of uses that can take place on MÁWUEĆ.
- → **Remediation and Restoration:** Tsartlip First Nation has undergone remediation efforts on certain areas with contamination. The Stewardship Department has also been leading riparian restoration efforts for KENNES Creek.
- → **Current amenities and uses:** MÁWUEĆ is mostly agricultural land with some residential buildings and farming facilities.



#### Addition-to-Reserve Decision and Process

Council decided to proceed with adding MÁWUEĆ to Tsartlip's reserve lands. Adding MÁWUEĆ to reserve is important to ensure the Nation can make self-determined decisions on how the land is used. We achieve this by removing the Provinces and Central Saanich's ability to decide what uses can and cannot take place on MÁWUEĆ through their regulations and laws.

In accordance with Council's decision, Tsartlip submitted a Reserve Creation Proposal to Indigenous Services Canada (ISC) in May 2021. ISC accepted the proposal in late 2021. Tsartlip and ISC have started working together on the various steps required to add the lands to reserve.

# Land Use Planning and Community Input

Once MÁWUEĆ becomes Tsartlip reserve land, the doors will open for Tsartlip's use and management of the lands. The land could be used for many purposes that will benefit Tsartlip community members including:

- → Food security
- → Cultural and traditional uses (such as medicine gardens)
- → Housing
- → Economic development
- → Institutional uses
- → Recreational uses

No commitments about land use have been made. A community dinner and visioning workshop is being hosted on May 29<sup>th</sup> from 5:00pm to 7:00pm at the Tribal School Gymnasium. Please join us and share your thoughts on how this land can serve the community.

## Next steps:

The next steps regarding MÁWUEĆ include:

- Continue ecological restoration initiatives,
- Continue monitoring contamination on site,
- Consult the community on their vision of the future of MÁWUEĆ,
- Finalize the addition-to-reserve process, and
- Advance the community's vision for MÁWUEĆ
